1. The Uganda Government has allocated funds to National Lotteries and Gaming Regulatory Board to be used for the acquisition of supplies and related services under framework contract for 18 months renewable once upon satisfactory performance as listed below from lot 1 to 12;

3. Bidding will be conducted in accordance with the open domestic bidding procedures contained in the Government of Uganda's Public Procurement and Disposal of Public Assets Act, 2003, and is open to all bidders from eligible source countries.

A complete set of Bidding Documents in English may be purchased by interested bidders on the submission of a written application to the address below at 7(a) and upon payment of a non-refundable fee of Uganda Shillings Fifty Thousand (Ushs. 50,000/=) or its equivalent in a freely convertible currency. The method of payment will be by deposit on the Uganda Revenue Authority Account against a bank

payment advice form issued by the Commission Cash office. No liability will be accepted for loss or late delivery.
