The Lotteries and Gaming (Fees) Regulations, 2024

(Under section 70 (1) and (2) (p) of the Lotteries and Gaming Act, Cap. 334)

IN EXERCISE of the powers conferred upon the Minister by section 70 (1) and (2) (p) of the Lotteries and Gaming Act, and on the recommendation of the National Lotteries and Gaming Regulatory Board, these Regulations are made this 13th day of September, 2024.

1. Citation

These Regulations may be cited as the Lotteries and Gaming (Fees) Regulations, 2024.

2. Fees

The fees specified in the Schedule to these Regulations shall be payable to the Board in respect of the matters to which they relate under the Act or the Regulations made under the Act.

3. Revocation of S.I. No. 6 of 2017

The Lotteries and Gaming (Fees) Regulations, 2017 are revoked.
